READ CAREFULLY

WAIVER AND RELEASE OF LIABILITY

In consideration of Summit Lake Entertainment Ltd. (hereafter known as SLE) furnishing services and/or equipment to enable me to participate in airsoft games, I agree as follows:

I fully understand and acknowledge that: (a) risks and dangers exist in my use of airsoft equipment and participation in airsoft activities; (b) my participation in such activities and/or use of such equipment may result in my injury or illness including but not limited to bodily injury, disease strains, fractures partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of SLE; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or part by the negligence or other conduct of the owners, employees, officers, or agents, of SLE or by any other person.

I on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify SLE and it's owners, employees, officers, or agents, from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of airsoft equipment or my participation in airsoft activities, I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, employees, officers, or agents, of SLE

I understand that SLE may be filming this airsoft activity and I agree to allow my likeness or voice in any form to be used in perpetuity without compensation.

I agree that if I am renting or borrowing any equipment from SLE that once in my possession that I am fully responsible for all damages resulting from my negligence, loss of, or theft of the equipment issued. I agree that I maintain this responsibility until I have *personally* returned each piece of issued equipment to an authorized employee of SLE. The equipment includes but is not limited to, a airsoft gun, goggles w/ facemask, barrel blocking device, armband, props and dead rag

I agree to always participate in the airsoft games only in accordance with the safety instructions and rules. I agree that if I do not follow these safety instructions and rules that I may lose my playing privileges without refund. I agree that this Waiver and Release of Liability will apply to any and all occasions when I participate in Airsoft activities of SLE, on or after the date that I sign this release. I understand that I will also be asked to sign this form again on subsequent visits. The Waiver is good through 31 December 2008.

I have read and understand the above Waiver and Release and by signing it agree it is my intention to exempt and relieve SLE from liability for personal injury, property damage or wrongful death caused by negligence or any other cause.
